

2011 CCR Pruitt Award

Deadline for Submissions: 12 noon EST, February 1, 2011.

Background and Purpose:

CCR is a leadership organization whose membership represents industry, academia and government. The mission of the CCR is to enhance research in chemistry-based sciences, engineering, and technology that benefits society and the national well-being through productive interaction among industrial, academic, and governmental research sectors.

The Pruitt Award is CCR's highest award, named after CCR founder Malcolm Pruitt. Its purpose is to recognize an individual record of outstanding contributions to the progress of chemistry and chemical engineering research by promotion of mutually beneficial interactions among universities, government laboratories, and chemical industry. It has been presented at the Annual Meeting since 1985.

A Board of Evaluators will read all eligible nominations (see below). The Board consists of members from government laboratories, universities, and industry. At the discretion of the evaluators, one outstanding individual may be presented the award during a special ceremony at the Annual Meeting May 1-3, 2011 in Detroit MI.

Nature of the Award:

The honor consists of an engraved award and may also – at the discretion of the Board - include a cash award to be given by the award recipient to an academic department in a chemistry-related field of his/her choice for the support of institutional and research activities.

Eligibility:

Nominees must be residents of the United States.

Nomination Documentation:

Nominations must include a full curriculum vitae or resume of the nominee and a narrative account of the career of the nominee, with particular attention to examples of successful leadership collaboration across institutional and sector boundaries. The nomination must be made by a Representative of a CCR member organization and must be supported by at least two additional letters from persons who are well acquainted with a nominee. (Nomination documents submitted electronically in 2010 may be resubmitted; only a brief letter reactivating the nomination is required. It is recommended that any updating materials also be included.)
